#### Guild Gets a Peek at the State Theatre

Members of the Guild enjoyed an October 21, Saturday morning tour of the renovation work going on in the State Theatre. Executive Director, Chris Parthemore walked us through the progress of the \$35M project following the catastrophic damage done on June 10, 2020 by a wind storm. His excitement over the extensive planning and upgrading was quite evident as members viewed and heard evidence of new amenities including improved sound and lighting, new concessions, restrooms, and handicap access that includes an elevator. According to Parthemore, "The new stage depth will increase from 25 feet to 43 feet, thus allowing a greater variety of shows."

### Cooke-Dorn Museum

Winter is here and the museum is quiet. Construction on the exterior stucco wall was completed just after New Year's day. If you haven't driven by the museum lately, all the equipment, scaffolding, tarping, barricades, work trailer and portapotty have been removed and the museum looks as it did preconstruction. That is except for the new stucco wall covering the north side of the museum. It now gives the appearance of the fine cut limestone blocks that cover the front and south side. It is a far more realistic facade than the previous surface through the use of techniques used when the home was relocated to this location in 1879. That should ensure that the stucco will last well over the hundred thirteen years the 1879 stucco had. It may last even longer since there is no ivy covering the surface that took place during the Dorn's ownership. Check out the pictures to see the finished wall and its resemblance to the actual limestone blocks and of how it compares to the back of the home which has not been redone.

The construction crew also installed a roof hatch to allow for easier and safer access to that area for routine maintenance, including removal of tree debris and leaves that collect behind the crenellated parapet and in downspout scupper boxes. They also point tucked the blocks on the north foundation and created a temporary fix to the interior section of the enclosed porch's rubber wall.

We are looking for volunteers to help guide visitors through the museum when it opens in spring. While the museum is closed, an effort is being made to make tout volunteering less burdensome by placing many informational rack cards throughout the home. This should alleviate the need to learn many of the particulars pertinent to the home and the objects within. # Cooke-Dorn Gardens & Grounds

# Betsy Berkey Chair, Master Planning Committee

Our new committee to restore the gardens and grounds of the museum is under way! In the fall first with Loretta Wilken, Lakeside Master Gardener and later with Tom Ott of Ott's Nursery to review the existing trees, shrubs, and plantings. Below is the summary of our meetings that includes discussions, evaluations, and future considerations. All recommendations will be made to our OHG board and upon approval, sent to the Ohio History Connection for review, support, and funding.



#### Cooke-Dorn Gardens & Grounds Committee

#### Master Plan Update

Our committee met on Saturday morning, October 28 with Lakeside's Master Gardener, Loretta Wilken. Committee members present included Betsy Berkey, Linda Howell, Sue Stuck, and Tim Berkey. Ed Stout and Dr. Keller were unable to join us.

We began our walk of the grounds by informing Loretta of the following:

- 1. We are interested in having her review the status of all trees and plantings and using her skills, provide a series of recommendations that could be implemented to restore the gardens and landscape to enhance the beauty of the property.
- 2. Tim asked Loretta to provide us with an estimated cost of her time to develop a full plan that could be implemented over multiple years in phases. Her fee would have to be reviewed and approved by our board to compensate her for her time.
- 3. Betsy asked her to consider all options and for the time being, consider nothing as sacred in terms of her recommendations. She is to be free to express all ideas that consider what should be eliminated, changed, or remain as is.
- 4. Members were free to ask questions, share ideas and opinions, and point out areas of concern. Ed Stout prepared suggestions and these were included with committee commentary.

#### Front Lawn:

Loretta stated that we should remove all plantings around the front trees for two reasons. First, doing so causes a competition for water with the trees. Second, a better look around trees is to keep things with a clean and natural appearance.

The front beds are too deep, and she recommends pushing them back. We included Ed's request to keep new plantings low. We asked if the present boxwoods could be moved. She could not predict if they would survive being moved, based on their size.

Loretta suggested adding higher plantings to the front corners to soften the appearance. She also recommended adding large urns in front of the entrance. We will begin to look for these and get prices and pictures she can review.

We looked at the small island around the flag holder. She understands the problem with dogs and will come up with some ideas. We also asked her about the long hedge on the south edge of the property. She wondered if the appearance fits with the age of the building and will put more thought into it. There was a concern expressed about how the neighboring property owner would feel about removal.

#### South Side:

Loretta examined the plantings and identified many of them. Some are ok but others are invasive. There is much going on and she will suggest what to keep and what needs to be removed. She asked for the identification of the property line.

#### Patio:

Members expressed an interest in beautification of the patio area so that it would be more appealing for events. We shared Ed's request to keep the hedge. Loretta thought we should keep it for privacy purposes and will examine the patio area for ideas.

#### **Back Yard:**

Trees - some of the trees along the south side are not in good condition. Loretta will evaluate all of the plantings. She recommended that we discontinue placing any plants around the large tree. We asked her if we should consider removal of the large pines in the back of the property. She recommended we have an arborist evaluate them as this is not her specialty but does not favor tree removal in general. Sue gave Betsy the name of an arborist who does good work. Loretta recognized the name and agreed he is reliable. Betsy will contact him and see if he can conduct an examination and provide an estimate of anything he recommends for removal. We asked her if the two red maple trees could be moved to provide a view of new gardens for that area. She said we should ask the arborist.

We walked to the area at the very back of the property behind the hedge. Members wondered if we could create a children's garden in that area. Loretta liked the idea and will follow up. Members liked the idea of creating a space to bring children and families onto the grounds. Another idea expressed was to create a kitchen garden against the garage between the greenhouse door and the service door. Again, she liked the idea and said it was possible. Members thought we should paint the concrete block white to make a more attractive appearance. This would have to be an approval with OHC, but regardless, some type of background for the garden would be helpful.

We showed Loretta the sculpture in the garage and asked if she could incorporate it in her plan. We also discussed having patio furniture powder coated for future use.

Water - Tim identified the water tie in in the back yard (located by Tracy and Ed) and expressed the consideration of extending it further to the rear to adapt a sprinkler system or perhaps a spigot station for the large presentation area in front of the semicircular hedge row as well as the proposed children's garden.

#### North Side:

We shared Ed's prediction that OHC would be implementing a handicap ramp along the side of the porch, thus eliminating plantings. We wondered if there would be room for a shallow bed to soften the look of the ramp. We looked at the rest of the plantings under the construction work leading to the front. We agreed that the present plants are not in good condition. Loretta will work on ideas to beautify this area.

#### **Conclusions:**

We are in the evaluation phase of the committee and will take time to work with Loretta to come up with a multi-year plan, along with estimated costs to eventually be presented to the board and OHC. In the meantime, any changes to the exterior grounds should be on hold. All ideas and requests should come through Betsy. This will ensure continuity of our work and allow decisions to be collaborative. The committee will need time to work with Loretta on fully evaluating possibilities and bringing an overall plan back to the board, including what should be considered for next year (year one). Members cited improvement of the front yard and north side appearances along with the ideas of a children's garden and kitchen garden as priorities for the coming year. Loretta will include these in her plan. She will be making frequent visits to conduct more extensive evaluations and take measurements. Betsy will be the lead contact for her and will call the next meeting when there are items for discussion.

Betsy will also take the lead in setting up a fall clean up date. She will be working with Linda and the Events Committee to solicit help from members and provide refreshments.

#### November 12 Meeting with Tom Ott

Our committee met on Sunday, November 12 at 2:00 p.m. with Tom Ott and his son (Ott Nurseries). Present were Betsy Berkey, Ed Stout, Tim Berkey, and Rick Keller. They walked the grounds and made the following evaluations:

Front Trees - were recently pruned and should be ok

Front/South Hedge - can be cut back, lowered, narrowed and fertilized in the spring

**Front Beds -** per Loretta's previous suggestion, the beds should be moved back 1-2 feet. Tom believed we could move the boxwoods but there is a chance some might not make it.

**Patio Hedge –** is fine, just needs trim work in the spring. He recommended killing the ivy underneath as it competes for water and hinders new growth.

**Back Yard** - Tom recommends taking down all of the tall pines in the rear as they are at risk to topple. They present a liability to the greenhouse and Cooke property as well as neighboring structures. He stated the evergreens behind the semicircular hedge are old and should be considered for removal. Tom stated he could move the red maples to new locations if desired.

**South Edge –** Tom recommended pushing back the ground cover (towards Lance's) to recapture lawn space.

**Tree Stumps -** Tom does tree stump grinding and can provide that service once the trees are removed. Tim suggested grinding the other existing trunks as well to provide garden space.

**Children's Garden -** Tom cautioned planting "butterfly plants" as they attract hornets and other stinging insects that could be harmful to children and adults with allergies.

**Fall Cut Backs** - Tom cannot perform the usual fall cut back of plants due to the restoration work being conducted. It was brought up that until the committee (via Loretta's advice) identify plants to be removed, it makes sense to hold on cut backs until spring.

Tom provided three contractors for tree removal bids:

- 1. Leimeister Crane & Tree
- 2. Buckeye Tree Service
- 3. Tree Experts

All three are local companies. Betsy will make calls to get bids.

### Follow Up

Subsequent to the last meeting, Betsy spoke to Ohio History Connection (OHC) Facilities Manager Saranne Hartley in two separate phone calls. The first call was to introduce herself as Chair of the Gardens and Grounds Committee and seek support, participation and input from OHC. The second phone discussion was to alert OHC of the danger of the leaning pine trees close to the greenhouse. Betsy followed up with a letter that included pictures of the trees along with bids submitted by local contractors to remove them. Some of you may remember that the greenhouse was destroyed a few years ago by a falling pine tree.

# Funding Our Work

### 2023 Candlelight Tour of Homes

The 2023 Candlelight Tour of Homes was another successful event. We heard from many attendees that they thought this year's event was the best one so far. That was really nice to hear. It validates that all of the hard work put forth by the many volunteers across the community was well worth the efforts. Financially speaking, the OHG made \$9,439.38 in net profit for the tour. Thank you so much to everyone who helped organize and participate in the event to make it the great success that it was!

#### 2023 Audit

The Bylaws of the Old House Guild call for an annual accounting of our revenues and expenditures. To comply with this requirement, I submitted a 63-page internal audit documenting all monthly receipts and expenditures, the resolutions from the minutes showing board approval of all financial transactions, and copies of December 2023 bank statements that verify ending balances from each of our accounts. A copy was provided to board members in advance of the January meeting, whereby the board discussed and approved the audit. Copies of the audit have been placed in the OHG files on the second floor of the Cooke-Dorn home. All of our files are accessible to members for review.

#### 2024 Tax Return

The Old House Guild of Sandusky is a 501c3 organization and thus is exempt from taxes that would normally apply to a business. The IRS has made it easier for nonprofits to file taxes via what is called a Form 990 which allows us to send an electronic short form postcard verifying our continued existence as a nonprofit. This is anticipated to be filed in January.

# 2024 Annual Budget

In 2022, the Guild adopted the practice of establishing an annual budget. This allows our committees to plan and estimate their activities more effectively. The largest budgetary item is the oversite of the Cooke-Dorn Museum and we rely on our site manager, Ed Stout to plan for the operational expenses that are supported by semiannual stipends provided by the Ohio History Connection. We are discussing the budget at our monthly meetings and should have it completed by spring.

### PayPal/Credit Card Payments

Last year, we established methods to pay membership dues as well as make donations to the Guild via PayPal through links made available on our website. I am pleased to share that we received \$557 in membership dues and donations utilizing this method during 2023. Those funds were transferred to our OHG bank account in early December 2023. For 2024, it is our hope to expand the use of this service by making it available to purchase 2024 Candlelight Tour of Homes tickets online.
